CALL TO ORDER: 7:55 PM

MINUTES OF DECEMBER 17, 1973, were approved as written upon MOTION by Mr. Coleman, seconded by Mr. Garrabrandt. Affirmative vote unanimous.

TREASURER'S REPORT for DECEMBER, was approved upon MOTION by Mr. Evans, seconded by Mr. Blastock. Affirmative vote unanimous.

AACJC MEETING: Mr. John Garrabrandt was appointed to represent the College and the Board of Trustees at the annual AACJC Meeting in Washington, D.C. during the week of February 18. An advance of \$520 for expenses was approved and added to the bills payable as voucher #233A.

The MOTION was made by Mr. Blastock, seconded by Mr. Coleman. Affirmative vote unanimous.

BILLS PAYABLE: included vouchers #1 through #233A totaling \$156,567.22; fund transfers covered by vouchers #234 through #240 amounted to \$37,520.26.

December payrolls were: Regular \$148,981.99
Work Study \$18,972.40

A MOTION by Mr. Evans seconded by Mr. Blastock approved payment of the bills, and the transfer of funds and acknowledged the December payrolls. Affirmative vote unanimous.

PERSONNEL: The resignation of Diane Halstead as secretary for the Curriculum Development Department, was accepted. The appointment of Debi Klimes as her replacement was approved on MOTION by Mr. Blastock, seconded by Mr. Coleman. Affirmative vote unanimous.

ATTORNEY'S REPORT: The resident manager and the Roping Club would like to know the intention of the Board concerning Frontier Field.

An additional inquiry has been made by the Green Acres subdivision property owners concerning the closing of the road that goes from Frontier Field through Green Acres subdivision.

ATTORNEY'S REPORT CONTINUED: The terms of the farm lease need to be reviewed.

The Chairman of the Board requested that Mr. Evans, Mr. Blastock and Dr. Taylor serve as a Committee to study these matters and make a recommendation to the Board in their February meeting.

Mr. Alexander also presented an insurance policy to the Board which gives additional coverage on the Brennan building.

UNSECURED EDUCATIONAL TRUST LOANS: in the amount of \$1,085 were approved on MOTION by Mr. Garrabrandt, seconded by Mr. Evans. Affirmative vote unanimous.

PRESIDENT'S REPORT: The miniature TV studio is now operative in the Vocational Building #1. It will produce colored video tape. It has been equipped on a grant from State Vocational Rehabilitation. It's first priority is to develop learning materials for the deaf students.

February 11-14 a 7 member team from the Idaho State Board for Vocational Education will evaluate our vocational program.

Friday the College received notice that \$70,000 is now available to prepare the working drawings for the new vocational building that was approved by the legislature last year.

The Idaho Power Company is proposing to the P.U.C. a rate increase of 12.5% that would amount to approximately \$9,300 a year of additional cost to the College.

The College has been on an energy conservation program since November. The following two month conparison with last year was presented to the board

Approximate savings in dollars for the two months \$2100.

This savings was made even though the New Vo-Tech Building was added during the year.

Gasoline consumption for the same two month comparison also showed a 197 gallon decrease.

Dr. Taylor asked for the Board's feelings on whether or not he should attend the hearings and what the stand of the College should be on the requested rate increase. No action was taken.

## PRESIDENT'S REPORT CONTINUED:

the legislature The Governor's message to Congress indicated a \$600 budget increase for the two junior colleges.

Dr. Taylor expressed optimism that the Governor would review his recommendation on the basis of the following:

- 1. The budget had been presented to the State on the basis of a percentage increase. The State Budget Office made their computation on FTE students and would have had to use the 1972-73 figures as they had not received the 1973-74 figures.
- 2. In prior years the FICA costs to the institution had been funded on a separate appropriation from the budget request. This year the College has been asked to include the FICA in the regular budget request. This would mean that the Governor's message would actually mean a decrease by the amount of FICA or approximately \$60,000 in his proposed budget.
- 3. In prior years the College costs for Public Employees Retirement have also been withheld from the appropriation actually given to the College. This would further reduce the budget proposal by the Governor.
