LOANS: Two loans for \$100 each to Hiroshi Shoji and Tim Santos, were approved on MOTION by Dr. Lehrman, seconded by Mr. Coleman. Affirmative vote unanimous.

EXPO PARKING LOT: An overrun of \$2,109.30 on the original bid of \$70,907.75 for the Expo parking lot construction was approved to Beymer Construction Company. Retention of the \$2,109.30 overrun was also approved until Beymer Construction could come in next year, when the weather permits, and complete the parking lot. There are two minor problems where the water does not drain. All of this was approved on MOTION by Dr. Lehrman, seconded by Mr. Coleman. Affirmative vote unanamious.
