He indicated that the City had originally selected an area that was not in accordance with the CSI Board. The Board then met with the City and suggested an alternate site. The City later indicated that they were not interested in the site selected by CSI. CSI again met with the City Council and offered three sites requesting that the City Council prioritize those and indicated to the City that the College would like to cooperate with them and do whatever is best for the community.

PRESIDENT'S REPORT: President Meyerhoeffer indicated to the Board that an

Economic Impact Statement had been completed and that he is planning luncheons with some of the business people and legislators as well as meeting with the Governor to promote CSI and indicate the economic influence on the community and the state.

A letter has been sent to the Water Resources Board requesting a management area to protect the geothermal resource. Jerry indicated that Joe McCollum has been very cooperative and worked very closely with the College on our mutual interest in the geothermal wells.

Jerry announced three appointments to the CSI Endowment Board. They are Miriam Breckenridge, Barney Erkins, and Jim Sinclair.
