MINUTES OF AUGUST 18, 1986, were approved as written on MOTION by Mr. Babcock. Affirmative vote unanimous.

TREASURER'S REPORT FOR AUGUST was accepted upon MOTION by Dr. Lehrman. Affirmative vote unanimous.

DISBURSEMENTS included vouchers #1 through #278 and #501 through #595 and #701 through #705 totaling \$1,106,542.32

SUBSTANCE ABUSE POLICY: Karl Kleinkopf of the Athletic Department presented a substance abuse testing policy for the board's consideration. After some discussion, the policy was tabled until a later date.

RESERVED SEATING IN THE GYMNASIUM: There was considerable discussion concerning reserving some seats in the gymnasium for basketball games. The MOTION was made by Dr. Lehrman that we approve the reserved seat concept with the details and implementation to be decided upon in a subsequent board meeting. Affirmative vote unanimous.

Board of Trustees Meeting September 15, 1986 Page 2

PRESIDENT'S REPORT: President Meyerhoeffer reported the following:

- 1. Friday, September 19, the Interim Legislative Committee will be on campus. The board is invited to attend. There will be at least two issues discussed. The first one will be the issue of governance. We would like to suggest that we form a closer coalition with the board by appointing one liaison board member from NIC and one from CSI to attend two annual board meetings: one being held at NIC and one at CSI. The second issue will be the funding proposal. President Schuler has suggested that it should be at a level of 50 percent state aid. The other possibility on funding would be the statewide property tax.
- 2. We had lobbied hard with the State Board of Education, and we were at their state board meeting at NIC. We felt that their recommendation on our budget was very good.
- 3. Enrollment is up this year. Last year the two community colleges had about 22 percent lower division students in the state. This year it could be as high as 25 percent.
- 4. We need to discuss with the board, at some future time, the possibility of requesting a new bond issue. Our present bond issue will be paid off next spring.
