## COLLEGE OF SOUTHERN IDAHO POLICY STATEMENT

WHEN A BOARD MEMBER TRAVELS FOR THE COLLEGE THE FOLLOWING POLICY WILL APPLY:

- 1. Air-line tickets for the board member will be paid for by the college. Air-line tickets for a spouse will not be reimbursed.
- 2. Room costs will be reimbursed by the college whether or not the spouse attends.
- 3. Meal costs will be reimbursed on the college per-diem basis for the board member.
- 4. Registration will be paid for both the board member and spouse; including business banquets or meals that are part of the conference.
- 5. The board reaffirms its policy that when the president of the college travels his or her spouse is encouraged to go. Expenses will be reimbursed for both the president and spouse.
