## PRESIDENT'S REPORT: President Meyerhoeffer reported the following:

- 1. Paula Edmonds-Hollifield has extended an invitation to members of the Board, faculty, and staff at the College to attend the drama production, Winners and Losers, being presented later this week.
- 2. A publication called, <u>Health Line</u>, has recognized the alcohol and drug program at the College of Southern Idaho. Our program has been in operation for over ten years. There were favorable comments in the article from the Walker Center.
- 3. Over 20 students from our mid-management program have qualified for the national competition at Salt Lake City.
- 4. The CSI speech team won four trophies at the national collegiate forensics tournament in Minneapolis, Minnesota, early in April.
- 5. Dr. Lou Bender has been invited to be the commencement speaker at the college graduation in May.
- 6. Bill Beale, head librarian at the college, has indicated that during February and March over 7,000 students used the library services.
- 7. President Meyerhoeffer indicated the proposed location of the new South Idaho Development Center along with development of parking areas.
- 8. A memo has been received from the State Board of Education awarding the College of Southern Idaho \$38,000 for preventative maintenance as well as repair of sidewalks at the college.
- 9. Contracts will be mailed out this week with a general increase of 3 percent.

MIKE GLENN indicated to the board that he had applied for a grant for the college for a rural community revitalization project. It would be a three-year project conducted in one of three towns in the valley.

- RECIPIENTS OF TEACHER EXCELLENCE AWARD: Chairman LeRoy Craig praised Penny Glenn and Jim Gentry for being chosen as teachers of the year. He also presented to each of them a \$1,000 check from the College of Southern Idaho Foundation and the Twin Falls Bank and Trust.
- RESOLUTION: A resolution was passed on MOTION by Mr. Babcock directing President Meyerhoeffer to sign the legal agreement with Professional Investor's Corporation on settlement of the geothermal law suit.

### PRESIDENT'S REPORT: President Meyerhoeffer reported the following:

- 1. He expressed his pleasure at the choice of two outstanding faculty members as teachers of the year and indicated that they were both highly thought of by students at the college.
- 2. President Meyerhoeffer, along with Mike Glem and Ed Peterson, make a presentation to the Permanent Building Fund Council on the South Idaho Development Center.
- 3. Summer projects reported are:
  - a. A new berm on the south side of the campus near the Library Annex.
  - b. The hatchery in Rock Creek Canyon is being expanded and should be completed by August 15, 1988.
  - c. We will take over the Burley facility on August 1, 1988 for our outreach program there.
  - d. If time permits, we will probably also complete a project at the baseball field.
- 4. Summer school should be a very active time at the College of Southern Idaho. We have a music camp planned, a dance camp, and several athletic camps.
- 5. Representative Jeannie Givens sponsored H.B. 666 in the Legislature this year requesting that each institution of higher education waive tuition and fees for two outstanding students during the school term. A MOTION to do this was approved by Dr. Lehrman. Affirmative vote unanimous.
