MINUTES OF APRIL 20, 1992, were approved as written on MOTION by Bill Babcock. Affirmative vote was unanimous.

TREASURERS REPORT: Acceptance of the Treasurer's report was approved on MOTION by Dr. Thad Scholes. Affirmative vote was unanimous.

EXECUTIVE SESSION:

Chairman Craig requested the Board enter into executive session in accordance with the provisions listed in Idaho Code 67-2345. The executive session was approved on MOTION by Dr. Thad Scholes. Affirmative vote was unanimous.

The Board adjourned to executive session in the President's office at 5:35 p.m.

RECONVENING OF BOARD:

The Board reconvened from executive session at 5:50 p.m. with Chairman LeRoy Craig presiding.

Dr. Thad Scholes made a MOTION to direct John Rosholt, legal counsel, to investigate and make recommendations concerning the continuation of the geothermal moratorium and possible other options that the College may have. Affirmative vote was unanimous.

BIDS:

- 1. The Board accepted the low bid for a new van from Con Paulos Chevrolet of Jerome in the amount of \$20,793.20 on MOTION by Bill Babcock. Affirmative vote was unanimous.
- 2. The Board accepted the low bid of the Computer Depot of Twin Falls in the amount of \$61,390 for the purchase and installation of a computer network system in the new Ag-Science building on MOTION by Dr. Thad Scholes. Affirmative vote was unanimous.
- 3. The Board accepted the bid of Hampden Engineering Corporation of Massachusetts in the amount of \$16,500 for an electrical control panel for the Physics lab in the new Ag-Science building on MOTION by Dr. Chuck Lehrman.

PRESIDENT'S REPORT: President Jerry Meyerhoeffer reported the
following:

- 1. Dr. Mike Glenn reported the Idaho Small Business Development Center located on our campus was the number one center in the State.
- 2. Several library sites were discussed and it was noted that CTA, the architecture firm that has done several campus buildings over the years, remained interested in the project. The Board agreed to finalize the site at a future date.
- 3. Dick Sterling reported on the summer maintenance schedule and the moves taking place this summer. He noted plans to remodel the Warberg house into a Student Health Center and the removal of the brown house on the corner of Washington and Falls.
- 4. The University of Idaho moved into the Evergreen (Ag-Science) building on May 11, 1992. We are in the process of moving into the Evergreen building. The move should be completed by mid-June.

- 5. Legal counsel Bob Alexander reviewed the final draft of the joint use agreement with the University of Idaho for the space they are occupying in the Evergreen building. He recommended approval. The Board affirmed the authority of President Meyerhoeffer to sign the agreement on MOTION by Donna Brizee. Affirmative vote was unanimous.
- 6. The Board discussed setting the budget for the Fy 93 on August 17, 1992. The purpose of the late budget date is to ensure that revenues from property taxes are exact rather than estimated. The Board also discussed operating on a continuing budget resolution for the months of July and August 1992. The Fy 92 budget authority would be used for these two months until the Fy 93 budget is set.

The Board approved the budget date of August 17, 1992 and the continuing budget resolution for July and August of 1992 on MOTION by Dr. Chuck Lehrman. Affirmative vote was unanimous.

- 7. The Board agreed to review a list from Bill Beale, CSI Librarian, concerning critical site factors for college libraries.
- 8. Dr. Jerry Beck reported that summer school started June 1 and that we were already at 91% of last years FTE. He also reported a 3 to 1 female to male student ratio.
- 9. Dr. Jerry Beck also reported on the micro-wave link being put into the Mini-Cassia jail to provide educational opportunities to State inmates being housed in the facility.
- 10. A consultant was at the College last week working on a \$350,000 to \$500,000 workplace literacy grant for CSI.
- 11. The President reported that the fall semester attrition rate was 11%. He also reported that four years ago the spring attrition rate was 18% but this year it was down to 9%.
