Special Joint Meeting Minutes

1. Dr. Thad Scholes moved that the College transfer \$1,200,000 from the General Fund to the Plant Facility Fund and authorize the loaning of the \$1,200,000 to the Dormitory Housing Commission for the purpose of buying the Northview Apartments.

This loan is to be repaid in full with an interest rate of 5% upon the issuance of revenue bonds by the Dormitory Housing Commission.

The Board of Trustees and Dormitory Housing Commission members discussed the above MOTION.

The Board unanimously approved the MOTION by Dr. Scholes.

2. Roy Prescott moved that the Dormitory Housing Commission accept the short term loan from the College and proceed with purchasing of the Northview Apartments. Eldon Evans seconded the motion. Affirmative vote was unanimous.
